

# Privacy Policy for the Vacation Rental

## 1. Introduction

We are pleased that you would like to book our vacation rental. The protection of your personal data is very important to us. In this privacy policy, we inform you about how we collect, process, and protect your data when you use our services.

## 2. Responsible Party

## 3. Collection and Processing of Personal Data

In connection with the booking and use of our vacation rental, we collect various personal data from you. This may include, but is not limited to, the following data:

- Name and contact details (e.g., name, address, phone number, email address)
- Payment information (e.g., bank details or credit card data)
- Booking details (e.g., check-in and check-out dates, number of guests)

## 4. Purposes of Data Processing

The collected data will be processed for the following purposes:

## 5. Legal Basis for Data Processing

The processing of your personal data is based on the following legal grounds:

- Contract fulfillment (Art. 6 (1) (b) GDPR): The collection and processing of your data is necessary to conclude and execute the rental agreement.
  - Consent (Art. 6 (1) (a) GDPR): In cases where explicit consent is required, we obtain this in advance (e.g., for processing special categories of data).
  - Legal obligation (Art. 6 (1) (c) GDPR): To comply with legal obligations (e.g., retention of booking data).
  - Legitimate interests (Art. 6 (1) (f) GDPR): In certain cases, we process your data to safeguard our legitimate interests, such as improving our services.

## 6. Data Sharing with Third Parties

We will only share your personal data with third parties when it is necessary to fulfill the contract or when we are legally required to do so. Possible recipients are:

- Payment service providers for payment processing
  - IT service providers (e.g., for the booking platform)
  - Tax and financial authorities, if required by law
- 

## **7. Data Retention Period**

We only store your personal data for as long as it is necessary to fulfill the purposes outlined above. After the statutory retention periods have expired, your data will be deleted or anonymized.

## **8. Your Rights**

You have the right at any time to:

- Request information about your stored personal data.
- Request correction of inaccurate or incomplete data.
- Request the deletion of your data (unless there is a statutory retention obligation).
- Request restriction of the processing of your data.
- Withdraw your consent to the processing of your data (if processing is based on your consent).
- Object to the processing of your personal data.
- Receive your data in a structured, commonly used, and machine-readable format (right to data portability).

You can exercise your rights by contacting us at any time.

## **9. Data Security**

We take all necessary technical and organizational measures to protect your personal data from unauthorized access, loss, or destruction. These include, among other things, encryption of data during transmission and secure storage.
